## **CONCLAVE 2008**

### Time to Place Your Bid

Do you want to host the next Conclave? The 48th Biennial Conclave at UCLA still brings a lot of good memories to mind but it is time for the Supreme Council to start considering where the next Conclave will be. The Supreme Council hopes to determine the location of the 49th Conclave in 2008 in late spring so now is the time to start putting together your bid.



If your chapter is going to submit a bid, you will need to gather information on facilities, room and board, accommodations, estimated transportation cost, scheduling windows, local area items of interest, etc., etc., now.

To submit a bid, go to <a href="www.alphachisigma.org/forms">www.alphachisigma.org/forms</a> and download the "Conclave Bidding and Hosting Guide" or call the National Office to obtain a copy. It details the considerations and all the information that must be included in a bid to host Conclave. Remember, the Grand Chapter has specified that Conclave facilities must be able to accommodate individuals with disabilities.

April 30, 2007 is the deadline for receipt of bids to the National Office to host the 49th Biennial Conclave in August 2008.



The Alpha Chi Sigma Educational Foundation as part of its mission to promote the advancement of chemical education provides loans to Alpha Chi Sigma collegiate members.

- The Interest Rates on new 2007 Mathews Student Loans is 5.8%.
- The interest rate for new Mathews Student Loans, available to any member of the Fraternity who is currently enrolled in school, is set annually at one percent less than the rate for US Government Student Loans.
- A member may borrow up to \$4,000.
- While a member remains in school only the interest has to be paid annually. Repayment of principle begins when the Brother leaves school.



## **Volunteerism Boosts Resumes for Collegians & Professionals**

While many collegians believe time spent volunteering could be better utilized by studying more, getting a part time job or partying, others see the benefits of volunteerism. Volunteers can receive a pat on the back or simply feel good about helping out a respectful cause. There are also long term benefits that can come from assisting others. On a resume, volunteerism suggests a strong work ethic, reliability and a commitment to something greater than oneself. It may seem trivial but anything that helps a resume stand out from the crowd is worth a little effort.


When preparing a resume, students should consider that employers may ask about anything listed and expect a well thought out response. Therefore, a volunteer tasked to serve lemonade for one day at a homeless shelter should probably omit that from the resume unless there is a long term volunteer relationship with the shelter. Volunteerism with religious, ethnic or controversial groups should be identified by task rather than by the group. This ensures that employers are not subconsciously discriminating based on the resume. On the other hand, exclusive membership groups such as Junior League or fraternal organizations should be listed as they may provide networking opportunities.

Students lacking direct work experience in a field of study can use volunteer opportunities to boost resumes by offering services or expertise the group may not have readily available. For example, a marketing student could approach small organizations that may need assistance with marketing communications or fundraising efforts. Law students can offer legal advice or research for organizations as well. Specific volunteer work relating to the field of study can be listed in the main section of the resume as a skills summary or work experience. Additional volunteer activities should be listed toward the bottom of the resume in a section titled "Volunteer Activities" or "Additional Information". Whether gaining experience in their field of study or simply displaying a commitment to an organization, students can highlight volunteerism in an effort to move their resume to the top of the pile.

## **Net Community – Coming this Fall**

The Fraternity is installing Net Community software this year in time for the fall semester. The Net Community software will give our members a number of electronic communities in which they can exchange ideas and information, and stay in contact with the National Office and each other - from the day they pledge!

This software will upgrade our National Website to allow all collegiate and professional chapters to host a website at the National Office. Districts and national committees will have the same ability. Every member will be provided an email address for life through alphachisigma.com.

Each Chapter will have one or more people who will be able to place and modify chapter information on the site. Anything chapters currently put on the web can be placed in Net Community. A chapter member who logs-in will see a customized page containing their:

- chapter calendars,
- chapter officer lists,
- chapter directories,
- chapter bulletin board,
- chapter photographs,
- district and national information,
- and more.

Officers will be able to access material directly relating to their office. They will be able to send and receive emails to people in that office, either in their district or the entire country. This ability to communicate easily with others in the same role will encourage the spread of good ideas and programs throughout the Fraternity.

Incoming pledges will be able to enter their personal information that is currently collected via master record cards. They will be able to pay their pledge and lifetime membership fees and update their address as needed. Pledges will have their status switched to Collegiate Member when they have gone through initiation.

Net Community is a perfect platform for the Professional Information Network (PIN). Finally, we will be able to post this information online in a secure setting that only Brothers can access. You will be able to search for Professional Brothers in your company, field, industry, or locale.

In addition to these features, members will be able to complete online surveys expressing member's needs, wants, and activities.

The potential of this software is vast, and just as I can barely scratch the surface in one page of what we will be able to do, we will not begin by using all the features. As the number of users increase and as we all become more experienced using it, we will expand the features available.

The end of the academic year is rapidly approaching. Please take the time to review the expectations that pertain to you, and let's all make an effort to complete as many of these as possible. The success of the Initiative is up to you and your efforts!

#### **Expectations for the Collegiate Chapters:**

- ✓ Achieve at least a One Star Chapter status
- ✓ Participate in a District/Regional Conclave (if applicable)
- ✓ Diversify Rush Activities Recruit Faculty/Graduate/Undergraduate
- ✓ Diversify Rush Activities Recruit from related majors
- ✓ Submit timely reports

#### **Expectations for the District Counselors:**

- ✓ Visit chapters at least once per year
- ✓ Build an effective District Committee
- ✓ Help chapters achieve at least a One Star Chapter status
- ✓ Hold a District Committee Meeting
- ✓ Set up a District/Regional Conclave
- ✓ Submit timely reports

#### **Expectations for the Grand Collegiate Alchemist:**

- ✓ Create expectations for Collegiate Chapters, District Counselors, and GCA
- ✓ Complete 2006-2007 Program Guide
- ✓ Add materials to the DC Toolkit
- ✓ Create additional support materials (Targeted Rush Brochures, Emerald Tablet, etc.)
- ✓ Communicate progress and relation to the larger picture
- ✓ Remove obstacles for the Collegiate Chapters and District Counselors

## Star Chapter Criteria – a review

To qualify for the **One-Star Chapter Award**, a chapter each academic year beginning July 1st and ending June 30th must:

- ✓ Return all Pledge & Initiation fees, Master Record Cards, Pledge Election Report, Pre- & Post-Initiation Reports to the National Office on time.
- ✓ Initiate a minimum of 8 or 1/3 of the number of current active collegiate members (reported in the preceding year's Active Collegiate Member Register) prior to June 30th of each year.
- ✓ Conduct two MAJOR service or professional activities. The report must include a description of the activity, its date, the number of brothers involved, and an estimate of the total number of people involved.
- ✓ Submit the Chapter Officer List within 2 weeks of each election.

- ✓ Submit the following reports by **June 30th** of each year:
  - Star Chapter Annual Report of Chapter Activities
  - Audit/Financial Statement
  - Charter, Ritual & Regalia Inspection Report
  - Active Collegiate Member Register.

To qualify for the **Three-Star Chapter Award**, a chapter each academic year beginning July 1st and ending June 30th must:

- ✓ Satisfy <u>ALL</u> the requirements for the One-Star Chapter Award.
- ✓ Maintain an Internet Web Page. This must include:
  - Information on pledging / membership
  - Current calendar of events
  - Current chapter and officer contact data
  - Professional / service activities
  - Link to the National Home Page
- ✓ <u>PLUS</u> accomplish any FOUR of the following:
  - Increase active collegiate member by 5% (active collegiate members reported in the preceding year's Active Collegiate Member Register is the basis.)
  - Conduct two <u>additional</u> MAJOR service or professional activities.
  - Conduct two Alumni related activities.
  - Conduct one additional MAJOR service or professional activity AND one Alumni related activity.
  - Submit the Professional Branch Induction Report 2 weeks prior to conducting either the Professional Recognition Ceremony (PRC) or the Professional Induction Ceremony (PIC). Include program and alumni speaker information.
  - Submit one or more nominations for National Fraternity Recognition Award (e.g. Scholar, Advisor, Kuebler).
  - Complete and submit a Chapter Plan for the year.

Maintain and submit a current copy of the Chapter's Bylaws to the National Office

# FROM THE NATIONAL OFFICE

### **Professional Branch Induction**

Professional Branch Induction (PBI) is the transfer of a member into the professional branch. Whenever a member is listed on the PBI form or marked "inactive" on the Active Collegiate Member Register, that member is transferred into the professional branch.

Send or fax the PBI form to the National Office at least 1-2 weeks prior to the ceremony to ensure the complimentary professional pin and GPA welcome letter will be received in time. (Please note that Lifetime Membership fees must be paid).

If your chapter wishes to hold a Professional Induction Ceremony (PIC) instead of the customary Professional Recognition Ceremony, contact GMC Showerman at <a href="mailto:gmc@alphachisigma.org">gmc@alphachisigma.org</a> or your DC for the ceremony and/or proper instructions.

  FORMS SECTION: Professional Candidate Form

  Although the majority of initiates into the Fraternity are enrolled in a Collegiate chapter, there does exist the provision to initiate Professional Candidates into the Fraternity. As Collegiate Chapters are the only group of the Fraternity that can initiate members, it is important to understand the differences in the Professional Candidate's qualifications, so that the Chapter can follow the correct procedure and submit the correct paperwork. As per the Bylaws of the Fraternity, there are two classifications for Professional Candidates. Those classifications are coded as "3a candidates" and "3b candidates" corresponding to the bylaw section that defines their status.

  3a If the professional candidate has a degree in chemistry or a related field, use this form for the written nomination. Only the chapter has to approve the nomination. Professional candidates thus nominated should be pledged and initiated using the normal procedure. The Master Record Card should indicate that the person is a "3a Professional Candidate."

  3b If the Professional Candidate DOES NOT have a degree in chemistry or a related field, use this form for the written nomination. Both the chapter and the Supreme Council must approve the nomination. As such, please try to notify the National Office of any 3b candidates as soon as possible so that the Supreme Council has time to discuss and vote on the candidate. If the nomination is approved, the proposing chapter will be notified and the candidate may be pledged and initiated using the normal procedure. The Master Record Card should indicate that the person is a "3b Professional Candidate."
