Alpha Chi Sigma Fraternity Supreme Council Minutes 31 July 2014

The Supreme Council met in the 1st floor lounge of the Balz-Dobie Residence Hall on the University of Virginia campus in Charlottesville, Virginia. Present were GMA Mark Evaniak B Σ '80; GCA Helen Webster AP '94; GPA Jonathon Wenzel Δ '96; GMC Kip Nalley A Σ '90; GR Patrick J. Johanns, A Θ '81 and AGR Marena Humphress. A list of those present for all or parts of the meeting is in Appendix I.

GMA Evaniak welcomed all in attendance and opened the meeting at 8:30pm.

- 1. The GMC will be keeping the to-do list.
- 2. The conflict of interest forms were discussed and distributed. No conflicts with the business to be covered were noted.
- 3. Charters that needed to be signed will be sent around to the members of the SC.
- 4. The distribution of materials to DCs were discussed.
- 5. A set of propositions needed for the start of a new biennium were passed. A list of all SC Propositions passed since July 27, 2014 can be found in Appendix II.
- 6. The new DC Chair is Merryn Cole.
- 7. Each grand chapter officer will be meeting with their predecessor to discuss the office
- 8. To-Do list activities were listed. The Motions passed by the Grand Chapter were reviewed and added to the appropriate to-do lists.
- 9. Professional Expansion More people should be involved.
- 10. Professional Branch Expansion Director Chair Kerri Federico will assume this role. The goals and timelines for professional expansion will be defined for the January meeting.
- 11. Web site upgrade Options for upgrading the website were discussed. Integration between the website and database is important. A timeline for updating is desired to be in place by January.
- 12. Corporate rates for hotels, cars, and like would be nice for travel. The GR will explore the possibilities of these at the PFA meeting.

GPA

- 13. St. Louis Pro There has been a lack of paperwork in the last two years and they did not send a delegate to Conclave. There is also a potential problem with a building that they may or may not own and the events they are holding that may generate liability for the Fraternity as a whole. Their insurance status is also unknown. The GPA recommends that we suspend their charter for one month to allow the investigation of these issues. Passed in proposition 4507.
- 14. LA Pro and RT Pro both may need some help with member retention. The GPA will be contacting all Pro Presidents to determine their challenges and current situation.
- 15. ACS Luncheon will be in San Francisco on Tuesday August 12, at John's Grill at 11:30 am. The cost for collegiate members will be free. The cost for professional members is \$25. Gary Anderson is hosting this event. It will be posted on Facebook.
- 16. PittCon Tim Deschaines indicated that this year's event will be in New Orleans and several people were included in planning for this event.
- 17. AIChE There has been little turnout at past events. Efforts will continue with the next meeting in Atlanta.
- 18. Solicitation The documents have been prepared. Including the Grand Chapter Directory in the solicitation mailing was suggested and will be considered.

GCA

- 19. Chapters not at Conclave None!
- 20. Chapters with deficient paperwork were mentioned and briefly discussed.
- 21. Gamma Phi is on probation due to hazing issues. The GCA and DC discussed the issue with the delegate and mapped out a path to resolve this issue.
- 22. There will be DC chats. Email addresses are being updated now and phone numbers will be exchanged.
- 23. MOPs will be sent out soon.
- 24. Business cards will be provided to DCs.
- 25. Collegiate Expansion Nothing new has come in recently.
- 26. Alcohol Awareness Training Alcohol awareness for chapters with members over 21 have been having issues because the university will not pay for the training. If they recruit undergraduate members, the university may pay for it.
- 27. The moving up of the deadline of the PBI reports may help generate a list of new professional members. This may be more efficient and allow better communication.

GMC

- 28. Sourcebook revisions and orders will be high priorities.
- 29. Token inventories will need to be evaluated. Lead in particular will need to be checked.
- 30. Delta Delta will be chartered if the petition is approved in the fall. Preparing for this installation will be a major project this fall.
- 31. The GMC feels that personal stories of professionals on the website and Facebook could be of value. Strategies for making this happen were discussed. The GMC will take the lead on this project.
- 32. The GMA will be working on the organizational/committee chart within 30 days.
- 33. Face Book pages will be set up for each SC office.

GR

- 34. PFA SC members will determine their schedules and interest in attending. Those who are unable to attend will inform the GR with questions or issues that they want investigated.
- 35. Minutes The minutes from the July 27th meeting are sent out.

Other issues

36. Questions were brought up regarding the suspension procedure and the suitable time frame for the disclosure of the outcomes of Grand Chapter motions.
